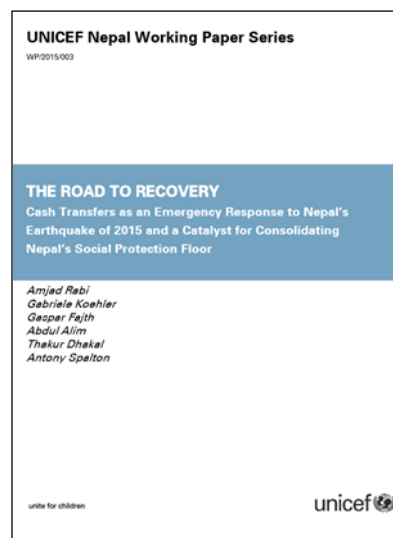

The Road To Recovery: Cash Transfers As An Emergency Response To Nepal's Earthquake Of 2015 And A Catalyst For Consolidating Nepal's Social Protection Floor by Amjad Rabi, Gabriele Koehler, Gaspar Fajth, Abdul Alim, Thakur Dhakal and Antony Spalton, UNICEF Nepal Working Paper Series WP/2015/003, 2015.

“This paper outlines a proposal to address the economic impact of the two earthquakes experienced in Nepal in April and May 2015 and possible further natural impacts connected to the earthquakes. It makes the case for two interventions - cash transfer programme in the 11 earthquake affected districts and universal child grant to all children under 5 in same districts. The proposed interventions will be based on Nepal’s existing government-funded social protection system. The proposed universal child grant, geographically targeted to the earthquake effected districts, would gradually be merged into the social protection framework that is under preparation by the Government of Nepal.” Unicef Nepal
